1 Introduction

A reference to a Clause or Appendix, unless stated otherwise, is a reference to a Clause or Appendix of this Schedule. Words and expressions shall have the meaning given in Schedule 1 (Definitions) of this RIO.

The Charges are exclusive of any applicable VAT and the Billed Party will pay such VAT in addition to the Charges.
